2. It will be mandatory for your school to impart education in Punjabi up to Xth level & C.B.S.E will definitely make arrangement to hold examination of Punjabi in such school & it also stated here that non-compliance with same will amount to the immediate annulment of No Objection Certificate.
3. After securing Affiliation with C.B.S.E, the Management of the school will committed to pay its teaching as well as non-teaching Staff, the Salaries and other allowance etc. at parity with the Government employees. Non compliance with the Same will amount to the immediate annulment of the No -Objection certificate

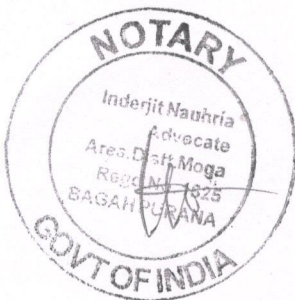
